Engineering Colleges at Jowai and Ampati:

A land of about 29.239 acres at Thadmuthlong, Elaka Shangpung for setting up of Engineering College has been taken over by DHTE on 30.10.2013 from Dorbar Shnong of Thadmuthlong.

A land of about 30 acres at Rongsanggre Village, South West Garo Hills District for setting up of Engineering College has been taken over by DHTE on 07.11.2013.

Govt. has sanctioned `10 crores for construction vide letter EDN.56/2014/34 dated 31.03.2014. Work not yet allotted. Money kept in P.W.D. deposit.

P.W.D has been requested to submit detail estimates for these construction to enable Govt. to accord administrative approval.

In the first phase, Engineering College in Ampati District is proposed to start initially with 4 years Degree course in Civil Engineering and that in West Jaintia Hills District with 4 years. Degree course in Electrical Engineering of 30-40 intake capacity in each College and with minimum infrastructure and human resource requirement.

Proposal for creation of posts for Engineering Colleges in Ampati and Jowai has been submitted to the Govt. vide our letter No. DHTE/TE/EC.32/2013-14/155 dated 15.09.2014 amounting to `84,30,190/- for each Engineering College and the Revised Cabinet Memorandum endorsed in Secretariat File No. EDN.237/2014/ dated 13.02.2015.

Further, P.W.D has submitted an estimate for construction of boundary fencing for Engineering College at Thad Muthlong (8th Mile), Elaka Shangpung, West Jaintia Hills District at an estimated cost of `4,92,50,000/- and the same has been forwarded to Education Department vide letter No. DHTE/TE/EC/32/2013-14/154 dated 08.09.2014 for according Administrative Approval. In this regard, Govt. is requested kindly to decide whether this amount of `5.00 crore already sanctioned for infrastructure of Engineering College at Thad Muthlong (8th Mile), Elaka Shangpung, West Jaintia Hills District can be utilized or not for boundary fencing.

PWD (Buildings) vide letter No. PW/SE/D/7/2014/15, dated 09.04.2015 submitted Architectural drawings for construction of Engineering College at Thad Muthlong (8th Mile), West Jaintia Hills District and Ampati, South West Garo Hills District. These Architectural drawings have been sent to the Director, NIT, Meghalaya, the Principal, Shillong Polytechnic and Jowai Polytechnic for checking the drawing. Views and comments on the Architectural drawing for construction of the above building was received from Jowai Polytechnic, Shillong Polytechnic and NIT, Meghalaya and the same have been forwarded to P.W.D (Buildings) vide letter No. DHTE/TE/EC.32/2013-15/322 dated 24.07.2015 and letter No. DHTE/TE/EC.32/2013-15/326 dated 12.08.2015 information is still awaited.

Williamnagar Polytechnic:

Govt. of India vide letter No. F.No.22-10/2008-TS.IV dated 31.12.2008 has sanctioned `12.30 crore for setting up of New Polytechnic at Williamnagar. The 1st instalment of `2.00 crore was released. Out of `12.30 crore, `8.00 crore will be spent on Civil works and `4.30 crore will be spent on Equipment, Machinery, Furniture, Transport and Learning Resource Materials as per instruction in the above letter. The 2nd instalment of `12.50,000/- vide letter No. F.No.22-10/2008-TS.IV dated 30.03.2009 and these amount of `2.00 crore +.125 crore was released to P.W.D for construction work. P.W.D has been furnished utilization certificate and the same has been endorsed in Secretariat file for necessary action from their end. Education Department vide letter No. EDN.327/2004/Vol.I/370 dated 22.05.2015 has submitted utilization certificate to MHRD.

Govt. of India MHRD vide letter No. F.No.22-24/2009-TS.IV dated 06.07.2015 has released the 2^{nd} installment ($^{\circ}$ 2,32,50,000/- + 45,00,000 + 22,50,000) = $^{\circ}$ 3 crores and Education Department vide letter No. DHTE/ESTT/TE.16/2004-15/484 dated 12.08.2015 has been requested to release the 2^{nd} installment of $^{\circ}$ 3 crore as sanctioned by Govt. of India for the above construction by Advance from Contingency Fund.

Functioning of this Polytechnic will be started as soon as the infrastructure is complete, posts created and filled up. The proposed Diploma courses are Civil Engineering and Electrical Engineering with intake capacity of 30 each.

Government vide letter No. EDN. 338/2009/167 dated 31.03.2014 has sanctioned an amount of `2.70 lakhs for setting up of new Polytechnics at Ri-Bhoi, West Khasi Hills and South Garo Hills Districts under Special Plan Assistance. This amount has been drawn by Directorate.

The land measuring of about 10 acres has been acquired by office through gift deed executed between the Deputy Commissioner, West Khasi Hills and Donors Shri. P. Dkhar and others. The said land was taken over by Education Department.

P.W.D (Buildings) vide letter No. DHTE/TE/PPP.20/2011-14/191 dated 04.08.2014 has been requested to prepare Detail Project Report along with Plan and Estimates for construction for the above building limiting the expenditure upto `8.00 crore each Polytechnic.

Land at Ri-Bhoi District has been identified at village Nongkhrah Nonglyngdoh the matter has been taken up with Director of Land Records and Survey, Meghalaya for surveying the said land. Survey was conducted on 08.06.2015 by the Land Records and Survey Department. The report of the land of area 76889.21 sqm alongwith the map have been submitted and forwarded to Education Department vide letter No. DHTE/TE/PPP.20/2011-15/220 dated 24.08.2015.

For the land at South Garo Hills District, Deputy Commissioner, Baghmara has been requested to identify a plot of land measuring approximately 15 acres free of cost and no information received till date though several reminders issued. DC, Baghamara has been requested again vide letter No. DHTE/TE/PPP.20/2011-15/239 dated 31.08.2015 and information is still awaited.

Pine Mount International Schools:

Land measuring 32.04 acres has been donated free of cost at Moorangtung, Wahiajer, Jaintia Hills District.

Land measuring 50.00 acres at Selbagre, West Garo Hills District has been offered on payment of compensation of `50 Lakhs.

Land of about 25 acres in West Khasi Hills has been taken over and registered by Deputy Commissioner, Nongstoin in the Lawse Village near Nongkhnum Island free of cost.

Education Department has directed DHTE to release the amount of `1.00 crores already sanctioned to P.W.D. (Buildings) to enable them to fence the land under possession of State Govt. Bank Draft No.103051 dated 09.09.2014 amounting to `1,00,00,000/- (Rupees one crore) only released to P.W.D vide letter No. DHTE/TE/PMIS/30/2011-14/197 dated 09.09.2014.

PWD (Buildings) has submitted Plan and Estimates for construction of boundary wall fencing of Pine Mount International School at Lawse, Nongstoin at an estimated cost of 1,51,06,000/- and construction of boundary wall fencing and an approach gate of Pine Mount International School at Moorangtung, Wahiajer, Jaintia Hills District at an estimated cost up to 2,25,63,800/- and the same has been forwarded to Education Department for according Administrative approval.

Government vide letter No. EDN 247/2010/152 dated 27.10.2014 has directed Directorate to float the Expression of Interest for Detailed Project Report (DPR) and thereafter to Design, Build, Operate and Maintain 3 Pine Mount International Schools in Meghalaya on PPP mode. The same has been float through DIPR vide letter No. DHTE/TE/PMIS/30/2011-14/216 dated 19th November 2014 for publishing of Expression of Interest.

Three Expression of Interest has been received and the same has been informed to Government vide letter No. DHTE/TE/PMIS/30/2011-15/251 dated 09.03.2015 with a request to instruct this Directorate on Expression of Interest submitted by the Firms for further necessary action and reply is awaited.

The proposal have been submitted to Government vide letter No. DHTE/TE/PMIS/30/2011-15/ 253 dated 17.03.2015 to take up with Finance Department for releasing the amount of `2,700.00 lakhs sanction by Government of India vide letter No. F.No. 44(3)/PFI/2014-1133 dated 12.12.2014 under Special Plan Assistance for establishment of Pine Mount International Schools at Jowai, Tura and Nongstoin. No sanction received till date.

Finance Department has been requested for releasing the above amount vide letter No. DHTE/TE/PMIS.30/2011-15/272 dated 26.06.2015. The expenditure of ` 30.00 crores (Rupees thirty crores) only may be met from the head of account "4202. Capital Outlay on Education, Sports, Art and Culture-01. General Education-203. University and Higher Education-(06)-Infrastructure Development under SPA/SCA etc. 53. Major Works Plan General" during 2015-16. The shortfall amount of ` 15.00 crore may be met by advance from contingency fund as per statement enclosed. Annexure II is enclosed herewith for favour of necessary action from your end.

B.Ed College in Jowai:

Deputy Commissioner, West Garo Hills has been identified the land for establishment of Meghalaya Technical University at Samingre Village, Jenggal, West Garo Hills District. The inspection of the land has been made by Education Department. As per inspection the area of the land is only 35 acres which is not sufficient to set up the University. DHTE has requested Deputy Commissioner, West Garo Hills to get some more land adjacent to the land already identified.

In response, Deputy Commissioner, West Garo Hills have identified additional land of about 30 acres adjacent to the land already identified on payment of compensation and another land about 100 acres at Jamangre Village which is 15 kms from Tura on payment of compensation. The DHTE vide letter No. DHTE/TE/STU/31/2011-14/140 dated 02.09.2014 has requested Government to provide fund for the land acquisition if the need of additional land is accepted.

Education Department has been requested to advise this Directorate whether the land of about 35 acres (free of cost) already identified at Samingre Village, Jenggal, West Garo Hills District will be taken over or not pending payment of compensation of additional land.

Directorate vide letter No. DHTE/TE/STU.31/2011-15/145 dated 21.01.2015 has requested Deputy Commissioner, West Garo Hills to make necessary arrangement with Nokmas of the concerned village for handing and taking over of the land already identified. Williamson Technical University. Proposal has been submitted to Govt. No. DHTE/TE/STU.31/2011-15/194 dated 09.06.2015.
