Sub:- Release of Preparatory Grants to the State of Meghalaya under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer the sanction of the President to release an amount of Rs.2,70,00,000/- (Rupees Two Crore Seventy Lakhs Only) as the 1st installment to be incurred to the State Governments of Meghalaya as Preparatory Grants under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) for the year 2015-16. Under the initiative under reference, the Central Government shall provide assistance to the State Governments for preparatory activities like Capacity Building, Planning etc., as per the guidelines under RUSA. The subsequent releases will be dependent on the submission of Utilisation Certificate for the earlier grants released.

2. Under RUSA, the Central Government shall provide assistance to the extent of 90% (in NER, J&K, Uttarakhand and Himachal Pradesh) and 65% of the outlay. The ratio of Centre to State share in the grants for Meghalaya is 90:10.

3. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release Rs.2,70,00,000/- (Rupees Two Crore Seventy Lakhs Only) of the allocation as the first instalment. Further instalments of the allocation shall be released by the Ministry only after the State Governments concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the first installment of the grant released.

4. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

After re-appropriation from 2552 -North-Eastern Areas, 00.789- Special component plan for Scheduled Casts, 02- University and Higher Education (Assistance to Universities), (5)- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant-in-aid General.

10. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

11. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

12. Necessary Sanction ID has been generated.

13. This sanction issues with the concurrence of Integrated Finance Division's Dy. No. 2227/15, dated 05-08-2015 and funds certified by the IF I Section vide their Dy.No. 440/15-IF.I dated 14.08.2015.

Reasons for Re-appropriation:


